

## Job description

- Job title: Curator (Professional Development)
- Contract: Fixed term (18 months), with the potential to become permanent, subject to funding
- Hours: 37.5 hours per week we are open to flexible work arrangements (4 or 5 days per week)
- Salary: £33,000 per annum (pro rata for part-time role)
- **Benefits:** Contributory pension, 22 days holiday per annum (pro rata for part-time role), bank holidays, birthday day off.
- Reports to: Interim Head of Professional Development and CEO
- Manages: Project assistants, facilitators and freelancers
- **Key internal relationships:** Head of Social Practice, Head of Operations, Head of Fundraising, Head of Communications and Marketing, Communications Manager, Administrator, social practice team
- Location: Flexible working from home, co-working in central London and at various ACAVA sites as required

## Purpose of the role

To work with the Interim Head of Professional Development, CEO and other colleagues on developing, delivering and evaluating ACAVA's new professional development programmes.

Activities will include (but are not limited to) curating and producing webinars, peer-to-peer networking, expanding our Artist-in-Residence programmes (young and emerging practitioners of the global majority), our work with young artists, new membership schemes and other initiatives as they emerge. There is significant potential to contribute to the evolution of this expanding area of our work, and you will be expected to bring ideas and ambition to the role.

## Key responsibilities

#### Programme development (with Interim Head of Professional Development)

- Develop new programmes that support our vision and business goals.
- Identify opportunities for collaboration that support our professional development strategy.
- Identify and apply to funding streams in collaboration with the Head of Fundraising and Interim Head of Professional Development.
- Cultivate and maintain relationships with a range of partners and collaborators.
- Advocate for ACAVA, engaging locally, regionally and nationally with the cultural, education, commercial and public sectors.
- Embed ACAVA's professional development programmes in our studio holder community, ensuring a responsive and collaborative approach to programme development.
- Visibly position ACAVA's programmes in the cultural and creative industries sectors.
- Design and schedule a programme of professional development activities throughout the year, in line with agreed objectives.
- Contribute to the future evolution of professional development initiatives.

#### **Programme delivery**

- Lead the programming of events and activities, including sourcing guest speakers/facilitators, booking venues and equipment, scheduling, marketing support and production.
- Ensure that programming is delivered on time, within budget and meets reporting and evaluation requirements.
- Produce internal and external programme reports and evaluation as required.
- Lead the recruitment of freelancers and contractors as required.
- Lead the recruitment of Artists-in-Residence.
- Ensure excellent pastoral and professional support for Artists-in-Residence before, during and after the period of the residency.
- Build and nurture an alumni group of Artists-in-Residence.
- Develop a plan (with structure, costs and timeline) for launching our new Associate Membership scheme in 2024.
- Work with the communications team to create and collate relevant content for newsletters, website and social media to promote and celebrate the programme.
- Work with colleagues to create an online library of resources including recorded content from live activities.
- Ensure activity complies with ACAVA's Respect, Safeguarding, Health and Safety and other relevant policies.
